



Levy Rates

Your property tax bill is determined by multiplying the levy rate (tax rate) against your assessed value (60% of fair market value). Levy Rates are determined by the Levying Bodies; County Boards of Education, County Commissions, Municipalities, and the State based on their annual budgeting needs. (Total tax rate is the sum of all individual Levying Bodies) The rates are then sent to The State Auditor for approval. Once approved, the Assessor applies the annual levy rate to the assessed value of your property and sends the books to the Sheriff's Department to begin the billing and collection process.

Excess Levy

The local levying body (Morgan County Board of Education) shall submit to the voters within their political subdivision, the question of the additional levy at either a general or special election. If at least a majority of the voters (50%) cast their ballot in favor of the additional levy, the County Board of Education may impose the additional levy. (If the county or municipalities need to impose an excess levy, an approval by 60% of voters is required). The Excess Levy may be imposed for up to 5 years and shall not exceed a rate greater than Class II - .4590, Class III - .9180. This rate is set by the State Legislature.

MORGAN COUNTY BD OF ED EXCESS LEVY

The Morgan County Board of Education, proposed an excess levy to be voted on at a special election held on May 11, 2013, for fiscal year **2014, 2015, 2016, 2017 & 2018.**

The proposed rate of the levy was set at 100% of the maximum allowable levy rate, **.4590**. (Previous 5 years rates were as follows; 2009-83.5% = **.3832**, 2010-88.5% = **.4062**, 2011-88.5% = **.4062**, 2012-93.8% = **.4306** & 2013-96% = **.4406**). 56% of Morgan County citizens rejected this excess levy. The Board of Education proposed the excess levy a second time, to be voted on at the primary election scheduled on May 13, 2014, with a proposed lower rate of **70%** of the maximum allowable levy rate (**.3216**). 54% of Morgan County citizens voted in favor of the excess levy. **This levy rate expired in 2019.**

Morgan County citizens voted May 8, 2018 to renew the excess levy at the same percentage, 70% of the maximum allowable levy rate (.4590).
Beginning July 1, 2019; July 1, 2020; July 1, 2021 and July 1, 2022.

Morgan County Citizens voted May 10, 2022 to renew the excess levy at the same percentage, 70% of the maximum allowable levy rate (.4590).
Beginning July 1, 2023; July 1, 2024; July 1, 2025 and July 1, 2026
